I. Meeting called to Order - Lisa Villa called the meeting to order at 2:42 p.m.

IV. Discussion Items - A. Curriculum Handbook - Lisa Villa reviewed the suggested updates to the Curriculum Handbook: Matching the Curriculum Committee Members section to the agenda lay-out, including the disciplines that fall under each faculty representative, the role of the DEIA+ Reviewer, and adding Total Student Learning Hours. The handbook will be brought to the 5/25 Curriculum Committee for a vote.

B. Tech Review & Curriculum Meeting Schedule - The committee reviewed the proposed meeting for 2023/2024 and agreed to meet on 12/7/23 instead of 12/14/23 for December.

C. AP 4020 Instructional Programs Curriculum & BP 4020 Program Curriculum and Course Development - The committee reviewed the AP and BP and had two small typographical fixes.

D. Creative Scheduling - Lisa Villa invited the committee to discuss creative scheduling in use in their divisions. Examples of successful and creative scheduling included: late start second 8 week classes, scheduling a 1-2 day non-credit course to support/augment an ongoing credit course, hybrid options (BUS/REAL/ACCT) to aid students working daytime, starting a few weeks after a term starts, ending prior to finals week (KIN), starting co-op ed classes late to recruit/promote to current students, hybrid combos with lab/discussion in person on one day and lecture online, promotion through external relations. Suggestions were made to improve the schedule display, including the part-of-term selection for non-standard classes.

V. Information Items - "5.6.5 Two-Thirds Lecture-Hour Equivalent (0.667 LHE) Assignments

5.6.5.1 Effective with the fall 2023 semester, all laboratory classes designated as .667 LHE will be designated as .75 LHE" - Dave Brown reviewed the MOU which increases any course with a lab factor of .667 LHE to .75 LHE for the fall 2023 semester.
