**IV. Discussion Items** - A. Updates on DEIA+ - Chair Lisa Villa led a review of a draft survey to be sent to all full-time and adjunct faculty regarding DEIA+ in the classroom and in curriculum. Revisions will be made to: list DEIA+ resources, split question about DEIA+ familiarity into classroom focus and another about adding to curriculum, provide examples of incorporating DEIA+ into classroom, and change question about serving as a lead to one about sharing practices with colleagues. After revision, the survey will be brought back for review.

**V. Information Items** - A. Standing Update - Articulation Officer - Michelle Plug reviewed recent bills at the state legislature. Neither AB 506 (to align ethnic studies courses with CSU) and AB 1749 (to expand guaranteed admission to UC programs) moved forward out of committee. AB 811 did move forward. It would require community colleges to allow students to repeat a course with a passing grade, if they receive notification of the impact on financial aid. It also requires priority registration to students who need a course for their major. AB 1111 and AB 928 passed committee and we can provide feedback online. The taskforce for AB 1111 ends this fall. The GE committee will convene in October.

**VI. Public Forum/Announcements** A. Dr. Hester presented longevity pins to Laura Kinnaman and Toros Berberyan for 5 years at Citrus College.

B. Brian Tong announced next Wednesday, Sept. 27th, from 10-1, there will be a transfer fair and asked the committee to spread the word to students. Dress in your alma mater clothing to take part in a photoshoot.
