**I. Meeting called to Order** - 2:42 p.m.

**III. Action Items** - A. Add ENGL 211 and ENGL 224/224H electives to English Literature A.A. - **M/S/P** - R. Gutierrez / N. Sullivan

**IV. Discussion Items** - A. DEIA+ in Curriculum survey update - The DEIA+ survey was sent out two Fridays ago; per Lan, already received 112 responses with one day to go. In response to a faculty member concerned about identifying info in the survey, the discipline declaration was made optional.

**V. Information Items** - A. Standing Update - Articulation Officer - 1) AB928, the CalGETC standards is undergoing revision and we will have results in the spring, 2) AB1111 work group is proposing to start off with top 20 courses and have common course numbering to start; legislators haven't seen enough progress yet; Chancellor's Office wants to know about why we don't have identical units (to minimize units overall) and this will be considered, however concerns about academic freedom may result in minimum units instead; The top 20 courses are those with the highest enrollment: Intro to Psych, Intro to Soc, Anatomy, ENGL 104, General Chem, etc... Looking at an intersegmental approach and trying to collaborate across segments, including UC. New task force starting in the spring to work on implementation, 3) repeatability bill did not pass, 4) Title 5 changes were passed by the Board of Governors, with many changes affecting GE degrees.

B. Academic Senate Syllabus workgroup - Workgroup initially created to work on DEIA statement for syllabus and other language people may want to include in syllabus. Want to create a syllabus handbook, centrally located and faculty driven, for faculty to use as a resource. Catie Besancon suggested including a formatted template like used at other colleges would help (particularly adjuncts) include important info like writing center hours, etc... Currently group includes Lisa Villa, Jeremy Clark, Ty Thomas and Nickawanna Shaw and want to include reps from all divisions. Right now still need VPA/KIN. If you currently need help on DEIA+ working, try reaching out to seasoned faculty and/or DEIA+ committee, or check with Ty on resources.

C. On the Course Currency Report, 26 out of 50 courses started review for the year. Lisa Villa will highlight courses in workflow that haven't moved forward in over a month. Lastly, if you are reviewing courses in your discipline, look for the specific discipline code in the drop-down box for approvers.

Heavy Truck Maintenance	S. Boldt	<p>Our industry partner Athens Services, approached us requesting a certificate that creates a pathway for an entry level style technician. Athens is working with the city of Pomona to generate job opportunities for the Pomona residents and Athens would like to use our diesel program as a pathway for those residents. Athens requested a certificate path that included training on basic shop safety, preventative maintenance inspections, proper repair order documentation, air brakes training, tire services, and basic hydraulic maintenance and repairs. Since we already have courses established that cover these areas (MTRK 101, MTRK 164, and MTRK 160) we decided that creating a new entry level certificate that includes these courses would meet the demands of not only Athens, but any future potential industry partner requiring entry level training for their technicians.
