I. Meeting called to Order - 2:43 p.m.

II. Approval of Minutes - Minutes from 10/19/23 Curriculum Committee - **M/S/P** - R. Gutierrez / N. Sullivan

III. Action Items - A. MATH 150 replacements in courses and programs - **M/S/P** - R. Gutierrez / N. Sullivan. Gwen will check to see if manual entrance skills can be added in CIM Course when non-course prerequisites added, e.g. "intermediate algebra" vs "MATH 150."

IV. Discussion Items - A. DEIA+ in Curriculum survey update -

Survey closed on 10/25. Lisa Villa is awaiting the results from Dr. Hao.

B. Total Contact Hours, Outside of Class Hours and Total Student Learning Hours -

Lisa Villa reviewed how to calculate each. See updated help text in the CIM Course Edit screen for these calculations.

C. 2024-2025 meeting schedule -

Putting the quick turnaround meeting in December meant there wasn't time to get those courses on the December BOT meeting. For next year, will move the meeting earlier in the fall.

D. Updates to CIM: Changed to Division Curr Rep instead of Discipline specific Curr Rep. Added and revised Help Text in CIM Course for Course Purpose, Instruction Type, Catalog Course Description, Credits, Major Course Content, and Course Textbooks/Resources, and in CIM Program for Program Requirements. -

Lisa Villa showed where help text added to the Textbooks section to remind originators to include the most recent textbook edition. Gwen reviewed the other updated fields. The approval workflow for courses and programs has been updated so that the Curriculum Rep step shows up under the division name instead of the specific discipline name.

E. Mirrored courses -

Currently a large number of mirrored courses coming through in NC. In 11/2/23 Tech Review, committee discussed adding a field to Course CIM to identify the mirrored credit course as well as adding a statement to the Course Description such as "This course is the non-credit equivalent of credit-course XXX." Gwen asked committee for ideas on a better numbering method for mirrored courses so that the different mirrored disciplines not mixed together in the catalog. Brainstormed ideas: 4 digit number with first number representing the division, adding 1-2 letters representing division to number and adding NC to the end of the discipline being mirrored. Dr. Hester would like to ensure no issues with Banner or COCI with any of these options - Gwen and Christine will check. Committee would also like to be able to search on mirrored course options in schedule. Smaller Academic Affairs group will research options and get back to committee with suggestion at 12/7 Curr Comm Mtg.
