#### **I. Meeting called to Order** - 2:42 p.m.

#### **II. Approval of Minutes** - Minutes from 11/16/23 Curriculum Committee - **M/S/P** - N. Desimone / N. Sullivan

**III. Action Items** - A. Mirrored Course Numbering - The Tech Review committee vetted the mirrored course numbering options suggested by Curriculum Committee on 11/16/23, including verifying with the Chancellor's Office and in Banner what is technically feasible.

Due to character limitations in Banner, and the desire to keep the mirrored courses logically grouped together, the Committee suggests mirrored courses follow the format: "NC [first two letters of discipline of mirrored credit course+course number]." As an example, the mirror of "AUTO 147" would be "NC AU147."

This format groups the mirrored courses together on the schedule directly following the regular NC courses, and keeps the related mirrored courses grouped together by their discipline subject. -

**IV. Discussion Items** - A. DEIA+ in Curriculum survey update - Review of results delayed due to focus on the Aspen prize submission. Lisa Villa will be discussing with Dr. Hao and Dr. Hester during winter break.

B. HVAC Non-Credit Courses and Certificate - These deactivations have been pending for several years. We are looking to deactivate these locally but hold on deactivating these at the Chancellor's Office in case there is future desire to reactivate.

**V. Information Items** - A. Standing Update - Articulation Officer - The Chancellor's Office will be sending out an update memo regarding changes to the local degree required by Title 5 updates. The deadline to implement these changes is being extended to fall 2025, however we do need to add an Ethnic Studies requirement effective fall 2024. Michelle also noted we need create a petition or bridge for students to move from non-credit to credit courses. Michelle asked if the mirrored classes intended to be just for non-credit students. Lisa confirmed they are, but there is a one-time option to apply for credit when taking an intro level introductory mirrored non-credit course. Dana clarified that this allows students a chance to take self confidence boosting non credit courses, but without creating a loophole for students to get around taking and paying for credit classes.

**VI. Public Forum/Announcements** - A. Our new curriculum specialist has accepted the job offer and pending BOT approval, will be starting in January.
