- b. Legislative Update: Proposed changes to Title 5: Academic Progress Notice & Academic Renewal (45-Day Notice for comments ends on 10/17/25) – *R. Rams*
 - i. Dr. Rams reviewed the notice received regarding the notification that input is being sought on proposed changes to Title 5 as it relates to academic probation and dismissal.
 - ii. The most substantial changes include:
 1. Revised naming convention from *proposal* to notice and from *disqualification/dismissal* to pause.

2. Requesting academic renewal more than once, with no unit limit. The only requirement is to have 12 units of 2.0 at any given time prior to the units being reviewed.
- iii. There will be a hearing at the North Orange Continuing Education Office (Anaheim) on September 16, 2025 for in-person as well as zoom participation. There is also the option to provide feedback via email.
- iv. Approval for this could require changes in workshops, website, printed materials, BP/APs, processes, etc.
