Committee Findings

The District has received and the COC has reviewed the financial and performance audits for the Measure G Bond Construction Fund for the fiscal year ending June 30, 2013. Vicenti, Lloyd & Stutzman, LLP, an independent auditing firm, prepared the reports to comply with Proposition 39 accountability within the California Constitution.

Vicente, Lloyd & Stutzman examined the Citrus Community College District’s compliance with the performance requirements for the Proposition 39 Measure G General Obligations Bonds for the fiscal year ending June 30, 2013, under the applicable provisions of Section 1(b)(3)(C) of Article XIII A of the California Constitution and Proposition 39 as they apply to the Bonds and the net proceeds thereof, and have stated, “In our opinion, the Citrus Community College District complied, in all material respects with the aforementioned requirements.”

Furthermore, they concluded that the District “has properly accounted for the expenditures in the Bond Construction Fund and that such expenditures were made on authorized bond projects” with no funds expended for salaries of school administrators or other operating expenditures.

Purpose/Responsibilities of the COC

The members of the Measure G Citizens Oversight Committee, with members representing various facets of our communities, serve as the eyes, ears, and voices of local residents and taxpayers, monitoring the expenditures of Measure G funds. The COC reviews the progress of the Measure G program and reports their findings annually to the Board of Trustees and you, the public. Measure G COC meetings are open to the public.
