We are pleased to report that our Measure G Citizens Oversight Committee had no concerns with the Citrus Community College District Measure G general obligation bond program.



For the fiscal year that ended June 30, 2018, the independent certified public accounting firm Vavrinek, Trine, Day & Co., LLP, examined the district's compliance with the requirements of the Proposition 39 Measure G General Obligation Bond Program, as specified in section 1(b)(3)(c) of Article XIII A of the California Constitution. The audit concluded that the district's Measure G financial statements present fairly, in all material respects, the financial position of the Citrus Community College District Measure G General Obligation Bond Construction Fund.

Citrus College's leadership and staff are to be commended for their conscientious management of Measure G dollars. At the same time, the support of local citizens should also be applauded. This continued collaboration will ensure that Citrus College remains a premier institution of higher education for years to come.
